JUKI® HOME SEWING MACHINE

LIMITED WARRANTY TO ORIGINAL PURCHASER

JUKI® UNION SPECIAL, INC. ("JUS") warrants this home sewing machine (the "Product"), excluding consumable parts (such as needles, loopers, feed dogs, knife blades, bulbs, lamps and belts) to the original purchaser to be free from defects in the materials or workmanship of the Product under normal use and service from the date of purchase, as follows:

1. for a limited warranty period of two years on motors, light assembly, wiring, switches and speed control; and
2. for a limited warranty period of five years on all other parts.

If at any time during the applicable limited warranty period, the Product is determined to be defective JUS will replace or repair the Product, at JUS's option. The Product is warranted only for normal household non-commercial use. This limited warranty does not cover damages due to acts of God, accidents, misuse, abuse, negligence, commercial use, or modification of, or to any part of the Product. This limited warranty shall be null and void unless the original purchaser (i) complies with all operating instructions in the manual provided or (ii) fails to have the Product periodically serviced and tuned by an authorized JUS dealer in accordance with the manual.

This warranty may only be used by the original purchaser of this home sewing machine. This limited warranty is not transferable to any subsequent purchaser and/or owner. Service under this warranty may only be obtained within the United States and Canada. (see instructions below)

JUS SHALL NOT BE LIABLE FOR ANY DAMAGE OR DEFECT RESULTING FROM THE USE OF OTHER THAN JUKI PARTS AND APPROVED SERVICE IN THE REPAIR OF THE PRODUCT. REPAIR OR REPLACEMENT AS PROVIDED UNDER THIS LIMITED WARRANTY IS THE EXCLUSIVE REMEDY OF THE PURCHASER. JUS SHALL NOT BE LIABLE FOR ANY LOSS OR DAMAGE OF ANY KIND INCLUDING INCIDENTAL OR CONSEQUENTIAL DAMAGES RESULTING DIRECTLY OR INDIRECTLY FROM ANY BREACH OF THIS LIMITED WARRANTY. Some states do not allow the exclusion or limitation of incidental or consequential damages, so this limitation may not apply to you.

THERE ARE NO EXPRESS WARRANTIES OTHER THAN THOSE DESCRIBED HEREIN. EXCEPT TO THE EXTENT PROSCRIBED BY THE APPLICABLE LAW, THE DURATION OF ANY IMPLIED WARRANTIES, INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ON THIS PRODUCT IS HEREBY LIMITED TO THE DURATION OF THIS LIMITED WARRANTY. This limited warranty gives you specific legal rights, and you may have other rights which vary from state to state.

To obtain limited warranty service the purchaser must deliver or send the Product postage or freight pre-paid, to the JUS dealer from whom the Product was purchased

or to such other place as may be designated by JUS, along with (a) the original dated bill of sale, (b) a copy of this limited warranty, and, (c) a written short description of the defect. JUS is not responsible for any damage that occurs to the Product during transportation to or from the purchaser.
